### Fish Kill in Biscayne Bay

We are passing a tipping point for the Bay not being able to support any life -- literally overnight, the Bay became a dead zone. On Monday morning, August 10th, Miami Waterkeeper's samplers and members of the public encountered about a dozen dead fish while conducting our weekly fecal indicator bacteria monitoring at Morningside Park. Miami-Dade County DERM monitoring groups conducted their routine monthly sampling nearby, noted very high water temperature (~90 F), and low dissolved oxygen levels.

## **Biscayne Bay Needs Better Pollution Rules, an Oversight Board and a Chief Officer, Task Force Says**



## **Biscayne Bay is Experiencing Localized Seagrass Die-offs**

Seagrasses are one of Biscayne Bay's critical habitats. Seagrass beds serve as a food source, a habitat for small marine organisms, and they regulate water quality by stabilizing sediments and cycling nutrients. However, seagrass cover in the Bay has drastically declined over the last decade. Miami-Dade County's recent report, "Report on the Findings of the County's Study on the Decline of Seagrass and Hardbottom Habitat in Biscayne Bay," highlights underlying factors that are causing these die-offs and provides a series of recommendations to help direct the County's approach moving


## Miami-Dade Back Bay Coastal Storm Risk Management



### Draft Feasibility Study

NORFOLK, Va. – The U.S. Army Corps of Engineers at the request of Miami-Dade County, its nonfederal sponsor, has extended the comment period for the Miami-Dade Back Bay Coastal Storm Risk Management Feasibility Study, due to the unprecedented amount of attention and resources needed to deal with the COVID-19 outbreak in the area. Originally scheduled to close on July 20, the comment period will now close on August 19..
